

Driving Directions:

Lower Level Hall & Ballroom Move-in

Directions to Lower Hall Tunnel/Dock:

I-40 West Bound

Exit 1D

Merge North on to Danny Thomas

Turn Left (West) on to A.W. Willis (Hwy 14)

Turn Left (South) on to Front Street

Go one block

Turn Right into the Pyramid/Bass Pro Entrance across from Shadyac Ave.

Take an immediate Left

Follow the access road South (parallel to Railroad tracks) through the fence gate to the Lower Hall loading dock. It will be on your left.

I-40 East Bound

Exit 1B

North on to Danny Thomas

Turn Left (West) on to A.W. Willis (Hwy 14)

Turn Left (South) on to Front Street

Go one block

Turn Right into the Pyramid/Bass Pro Entrance across from Shadyac Ave.

Take an immediate Left

Follow the access road South (parallel to Railroad tracks) through the fence gate to the Lower Hall loading dock. It will be on your left.
